Summer Camp Waiver and Release of Liability Form

In consideration of Xilin Northwest Chinese School ("Xilin NW") allowing any and all children and/or accompanying adults who enter the facility under the direct or indirect supervision of the undersigned (all of whom are hereinafter collectively referred to as "the Participant"), to use the Summer Camp facilities (Premise"), I hereby for myself, the Participant, their heirs, executors, administrators, or anyone who might claim on their behalf warrant and agree as follows:

- 1. That I recognize that playing in the Premises does involve a certain normal inherent risk of injury as does playing at any playground with any such play equipment
- 2. That I am either the Participant's parent, guardian or have been duly authorized by their parent or guardian to execute this waiver on their behalf.
- 3. To waive any and all claims that I have, or the Participant may have, now or in the future against Xilin NW and their Board, Directors, Officers, employees, staff, contract teachers, agents, and representatives (all of whom are hereinafter collectively referred to as the "Management").
- 4. To release and discharge the Management from any liability for any injury, loss, damage, or expense to person or property that I or the Participant may suffer as a result of the Participant using the premises.
- 5. To hold harmless and indemnify the Management from any and all liability for any property damage or personal injury to any third party, resulting from the Participant using the Premises and participation in the Summer Camp.
- 6. To indemnify the Management from all costs and claims brought against the Management on behalf of the Participant.
- 7. That I will learn the safety rules and ensured that the Participant be made aware of and understands them. I warrant that the Participant is in the good physical condition and physically able to play in the premises.
- 8. That I understand that while participating in this activity, my child may be photographed. I agree to allow my child's photo, video, or film likeness to be used for any legitimate purpose by Xilin NW the activity holders, producers, sponsors, organizers and assigns.
- 9. That this agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, and assigns. I have read and agree to the terms and conditions as set out.
- 10. That in the event of illness, injury, and/or accident occurring in the Premise, I authorize the camp instructor or any Xilin NW employee, staff, contact teacher, agent, or representative to act on my behalf. They may approve any and all non-emergency or emergency treatment and are authorized to sign any and all medical release or required form(s) on my behalf. In the event of an emergency, I understand that I will be notified of the situation as soon as practicable. I agree to pay any necessary expenses not covered by Xilin NW accident policy incurred in the medical treatment of my child, including, but not limited to all transportation costs to and from a medical facility, and, if necessary, transportation to my home or medical facility of choice.
- 11. That I understand that the Xilin NW may, in its sole discretion, dismiss any camp participant for inappropriate, disrespectful, unlawful, illegal, or dangerous behavior at any time. In this event, I understand that I will not receive a refund of camp fees for unattended days. If my child breaks or damages any property as a result of their direct or indirect actions. I hereby agree to pay for its repair or replacement.

I have read and agree to the terms and conditions as set out. I understand that by registering for the Summer Camp, I hereby waive the above referenced legal rights, including the right to sue.
